2. Aarogya Health Care Centre & Ayurvedic Panchakarama, Partapur, Meerut having its registered office at Partapur, Meerut which is committed to providing quality patient care, and improving lives.

Purpose:

The purpose of this MoU is to establish a mutual agreement between KDC and Aarogya Health Care Centre & Ayurvedic Panchakarama, Partapur, Meerut to provide oral-dental care services along with tobacco cessation counseling to patients, staff, and faculty at nominal charges.

Terms and Conditions:

1. Provision of Services:

KDC shall offer comprehensive oral-dental care services to the beneficiaries from Aarogya Health Care Centre & Ayurvedic Panchakarama, Partapur, Meerut, that not only include consultation, diagnosis, treatment, and regular follow-ups but all advanced treatments like implants and orthodontic treatments will be provide by our specialized and experienced doctors. Routine dental check-ups and consultations.

2. Eligibility:

The services shall be made available to all persons reporting from Aarogya Health Care Centre & Ayurvedic Panchakarama, Partapur, Meerut.

Beneficiaries must present a valid school ID card or a letter of affiliation from Aarogya Health Care Centre & Ayurvedic Panchakarama, Partapur, Meerut to avail of these services.

3. Nominal Charges:

The cost of the services provided shall be on a nominal basis, with a specific rate chart pre-agreed upon by both parties. Preventive health camps may be organized at the school premises at no cost for screenings.

4. Facilities and Infrastructure:

KDC shall ensure the availability of trained dental professionals, modern equipment, and infrastructure to deliver high-quality dental care.

5. Referral System:

Complex cases beyond the scope of general dental check-ups requiring advanced care shall be referred to appropriate specialists within Kalka Dental College & Hospital.
